

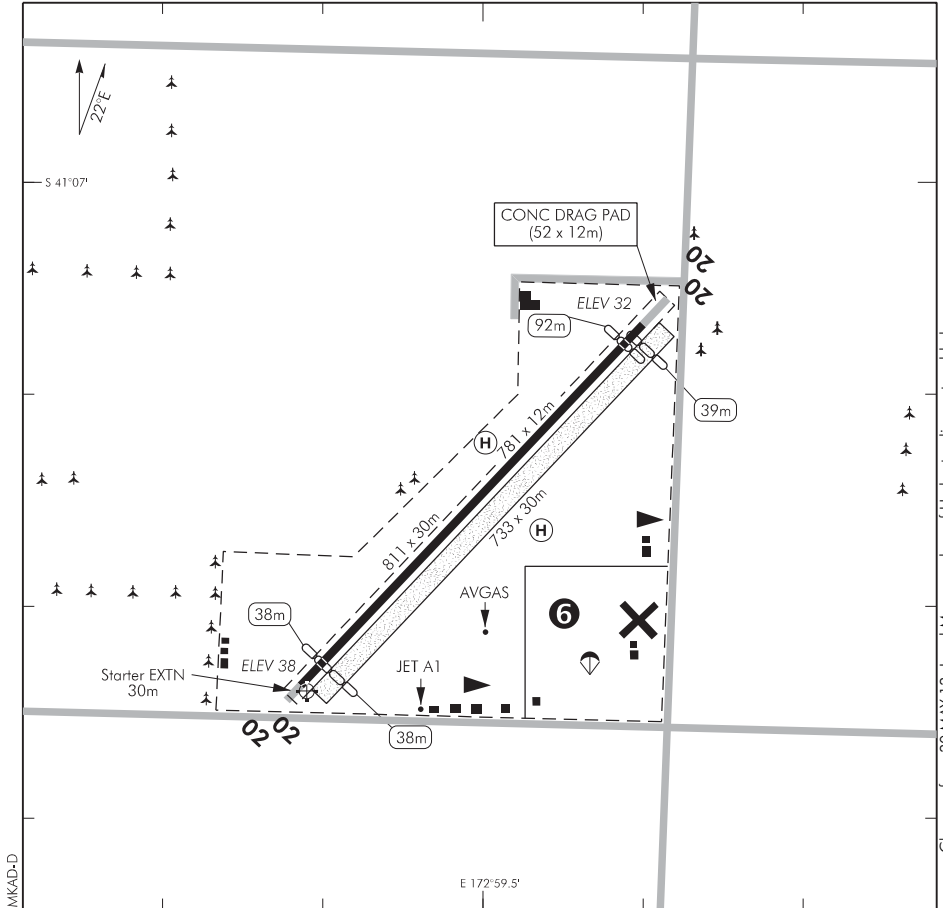

Changes from 30 MAY 13: Local Memorandum of Understanding note added.

1. Pilots must not join overhead during parachute operations which can be very frequent. All pilots intending to join overhead must ensure it is safe to do so.
2. Extensive aircraft training occurs in surrounding airspace.
3. Microlight aircraft towing hang gliders operate to 3000ft and at times up to 5000ft with gliders descending and landing on the west side of the airfield. Gliders are radio equipped.
4. Extensive helicopter training may take place from any point on the aerodrome, particularly from the helipads marked by painted tyres.
5. Simultaneous operations on parallel paved and grass runways prohibited.
6. Parachute landing area. Parachute operations daily.
7. Aerodrome closed periodically to all aircraft, other than approved operators due to drag racing — Refer NOTAM.
8. **CAUTION:** High trees on northern end of runway on approach to RWY 20.
Significant undulations in Gr RWY 02/20.
Mowing of runways and operational areas may take place at any time.
